Morning Session – 10am to 1pm

The first half of the day will assist members in developing an understanding of the law, regulations, and protocols that affect the trade of farm products from the farm gate to the end consumer.

In producing a product that enters the UK and global food chain, members' clients are governed by a complex web of rules and protocols from contracts with grain merchants and meat processors as it leaves the farm gate to the rules of trade with other countries.

Our panel of **Nicola Spence, DEFRA Chief Plant Health Officer; Fiona Smith, Lecturer in International Economic Law at the University of Warwick; Cecilia Pryce, Market Analyst at Openfield** and **Christopher Dodds, Executive Secretary of the Livestock Auctioneers Association** will share their wealth of experience in this area to provide delegates with up to date practical knowledge on a complex area of the agricultural industry.

Afternoon Session – 2pm to 4pm

Following lunch, we will focus on a refresher on Compulsory Purchase and Compensation in Law and Practice, including the implications of changes to the legislation arising from the proposed Neighbourhood Planning Bill.

With a growing commitment from Government for investment in infrastructure projects, this area of practice is likely to increase in activity for members over the next few years.

Our panel of **Barry Denyer-Green of Falcon Chambers; Jonathan Perks of Fisher German and Zena Hanks of Saffery Champness** will provide delegates with an up-to-date practical view on the law and compensation under CPO and the tax implications of CPO projects.
